REQUIREMENTS FOR SUBMITTING AN APPLICATION FOR CERTIFIED GENERAL APPRAISER

The attached application is intended for use by applicants for Certified General Appraiser. The qualifications required by this classification are set forth in *The Real Property Appraiser Qualification Criteria and Interpretations of the Criteria* (Real Property Appraiser Qualification Criteria Effective January 1, 2008; Appendix, Real Property Appraiser Qualification Criteria Prior to January 1, 2008; Includes All Interpretations and Supplementary Information as of February 1, 2007) issued by the Appraiser Qualifications Board of the Appraisal Foundation, and Board Statutes and Rules.

All entries must be typewritten or printed in ink. If you do not answer **EVERY** question, and include all required attachments with required highlighting, your Application will be considered incomplete and will delay the issuance of your Certificate.

1. FEES

\$400.00 APPLICATION FEE:

- a. Submit certified check, cashier's check or money order payable to the Arizona Board of Appraisal. Do not send personal checks or business checks. Cash in the exact amount will be accepted if paid in person at the Board office. Application fees are nonrefundable.

\$24.00 FINGERPRINT CARD PROCESSING FEE - REDUCED FEE OF \$22.00 EFFECTIVE MARCH 19, 2012

- a. Submit a fingerprint card completed by a fingerprint technician, along with a CASHIER'S CHECK, CERTIFIED CHECK or MONEY ORDER in the amount of \$24.00 payable to DPS. Cash will not be accepted. Do not fold or staple the fingerprint card.
- b. To obtain a fingerprint card, pick one up from the Board office or send a **9" x 12" self-addressed envelope** to the Board office. The fingerprint card received from the Board office **must** be the card used for fingerprints because it has specific agency data preprinted on it. Fingerprinting agencies are listed in the local phone directory.
- c. It takes about 4 weeks to receive fingerprint results from the FBI. Results will be submitted to the Boards office.

\$80.00 NATIONAL REGISTRY FEE

- a. **DO NOT SUBMIT WITH THE APPLICATION.** Once the Board has notification **DIRECTLY FROM THE TESTING COMPANY** that the applicant has passed the examination, applicant will be notified by the Board IN WRITNG and payment of the National Registry fee will be requested. Upon request for payment of the National Registry Fee, make certified check, cashier's check or money order payable to the Arizona Board of Appraisal. Do not send personal or business checks. Cash in the exact amount will be accepted if paid in person at the Board office. Upon receipt of payment of the National Registry Fee, the certificate will be issued.

2. DOCUMENTATION OF EDUCATION:

- a. 300 qualifying course hours as specified by Appraisers Qualification Board 2008 Core Curriculum. Applicant must submit verification of all education courses which are listed on the application by attaching to the application the certificate or transcript reflecting the successful completion of each course **IN THE SAME ORDER AS LISTED ON THE APPLICATION.**
- b. Qualifying education courses taken through distance education **MAY NOT EXCEED 75% OF THE REQUIRED 300 HOURS.**
- c. A USPAP course taken through distance education or taken more than two years preceding the date of the application **WILL NOT BE ACCEPTED.**
- d. All courses must be approved to meet the 2008 Core Curriculum by the Arizona Board of Appraisal **OR** by another state. Proof of course approval to meet the 2008 Core Curriculum by another state must be submitted. Courses that are not approved **to meet the 2008 Core Curriculum** by the Arizona Board of Appraisal or another state **WILL NOT BE ACCEPTED.** The submitted certificates for courses approved by the Board **must be** on the Board's form of certificate. A list of Arizona-approved qualifying education courses is updated monthly on the Board's website.

3. **DOCUMENTATION OF BACHELORS DEGREE, OR HIGHER, FROM AN ACCREDITED COLLEGE, JUNIOR COLLEGE, COMMUNITY COLLEGE, OR UNIVERSITY:**

- a. Applicant must attach a copy of applicant's bachelors degree, or higher, **OR** college transcript of successfully passing a total of at least 30 semester credit hours of collegiate subject matter courses in (1) English composition; (2) micro economics (4) macro economics; (4) finance; (5) algebra, geometry or higher mathematics; (6) statistics; (7) introduction to computers—word processing/spreadsheets; (8) business or real estate law; and (9) two elective courses in accounting, geography, ag-economics, business management, or real estate. Applicant must number the courses listed on the transcript to match these required subject matter courses.

4. **EXPERIENCE LOG:**

- a. Applicant must log **ACTUAL** time spent on each appraisal. **ACTUAL** time requirement for certification is 3000 hours in not less than 30 months. Refer to the Criteria concerning what is considered **ACTUAL** time. Experience must have been acquired within ten years immediately preceding the filing of the application.
- b. Sample appraisal reports will be accepted as provided by the Criteria. There need not be a client in a traditional sense (i.e. a client hiring an appraiser for a business purpose) in order for an appraisal to qualify for experience, but experience gained for work without a traditional client cannot exceed 50% of the total experience. All sample reports must be true appraisals of a subject property.
- c. At least 1500 hours must reflect nonresidential appraisals. The applicant must be named in each appraisal report as a significant contributor. The term "significant" means the contribution must be of substance to the development of the assignment results. A trainee who merely collects or provides data for use in the analysis does not provide significant appraisal assistance. Examples of contributions made by trainees that constitute significant appraisal assistance include the identification of comparable properties and data, inspection of the subject property and comparables, estimating accrued depreciation, or forecasting income and expenses.
- e. 75% of applicant's experience must include work product where applicant inspected the subject property. Follow the specific Instructions for Completing the Experience Log.

5. **SUPERVISING APPRAISER'S NOTIFICATION OF ENGAGEMENT/TERMINATION OF TRAINEE:**

- a. Applicant must submit a copy of the signed Supervising Appraiser's Notification of Engagement/Termination of Trainee provided to the Board by each of applicant's supervising appraisers.
- b. **NOTE:** Pursuant to A.A.C. R4-46-201(D)(4), as of 1/1/07, each supervising appraiser is required to file the form with the Board for each of his/her trainees; ; **AND** as of 5/31/08, a supervising appraiser who does not file the form with the Board may be subject to disciplinary action and the trainee will not receive credit for hours logged during the period that the supervising appraiser failed to file the form with the Board.

6. **APPLICANT WHO HOLDS A CURRENT ARIZONA LICENSE:**

- a. **Education:** Refer to Requirements #2 and #3, above. Applicant must provide proof of a 15-hour National USPAP course **TAKEN WITHIN TWO YEARS PRECEDING THE DATE OF APPLICATION.** **Note:** A License holder who was licensed through reciprocity must provide proof of all education as outlined in Requirements #2 and #3, above.
- b. **Experience:** Refer to Requirement #4, above. However, if the experience for applicant's current license/certification was obtained less than ten years ago, applicant must provide only proof of experience for the required additional experience hours for Certified General certification. The total 3000 hours must be obtained in not less than 30 months.
- c. **Note:** A License holder who was licensed through reciprocity must provide proof of all experience as outlined in Requirement #4, above.

7. **APPRAISAL REPORTS REQUESTED BY THE BOARD:**

- a. **DO NOT SUBMIT WITH THE APPLICATION.** Upon receipt of the application, appraisal reports will be selected by staff from the experience log and requested in writing from the applicant. Three (3) of the selected reports must be current within two (2) years immediately preceding the filing of the application
- b. Additional reports may be requested by the Board.
- c. The applicant must be named in the report as a significant contributor. The term "significant" means the contribution must be of substance to the development of the assignment results. A trainee who merely collects or provides data for use in the analysis does not provide significant appraisal assistance. Examples of contributions made by trainees that constitute significant appraisal assistance include the identification of comparable properties and data, inspection of the subject property and comparables, estimating accrued depreciation, or forecasting income and expenses. No information on the submitted reports can be redacted or missing. The submitted reports must be signed.

8. **DOCUMENTATION OF ANY "YES" ANSWERS TO QUESTIONS 10 THROUGH 20 INCLUSIVE:**

- a. If you answer "YES" to question 10 through 20, inclusive, provide a signed, detailed statement describing the facts and circumstances, including the date and location of the incident or event.

 - 3) For **DISCIPLINARY ACTIONS**, a **CERTIFIED** copy of (1) Notice of hearing and/or complaint; (2) Answer; (3) Findings of Fact and Conclusions of Law; (4) Final Order/Administrative Ruling; (5) Consent or Settlement Agreement; (6) Certified License/Certificate History from each state, except Arizona, in which applicant is licensed/certified at the time of application.
 - 4) Provide any other documentation that the applicant believes supports the applicant's qualifications for licensure/certification or additional documentation that the Board may require.
- c. **Note:** If you attempt to obtain the required documents and are told that records have been destroyed or are otherwise unavailable, obtain a written statement to that effect from the agency and court. ***Do not detach or unstaple certified documents. Documents must remain in original order received.***

9. **ARIZONA STATEMENT OF CITIZENSHIP AND ALIEN STATUS:**

- b. **Note:** According to the Board rules, an applicant must meet all requirements for a license or certificate within one year of filing the application or the applicant's file will be closed and the applicant must reapply. Application fees are nonrefundable.

11. **EXAMINATION:**

- a. Once the application has been approved by the Board, applicant will be provided written notice from the Board with the Arizona Appraiser Approval Form necessary to take the examination.

1/09 BOARD ADOPTS SUBSTANTIVE POLICY STATEMENT #5, GUIDELINES FOR EVALUATING EXPERIENCE FROM A LICENSED OR A CERTIFIED RESIDENTIAL APPRAISER WORKING TOWARD A NEW CLASSIFICATION. On January 15, 2009, the Board adopted Substantive Policy Statement #5, Guidelines for Evaluating Experience from a Licensed or Certified Residential Appraiser Working toward a New Classification. The substantive policy statement reads as follows:

**ARIZONA BOARD OF APPRAISAL
SUBSTANTIVE POLICY STATEMENT #5**

**GUIDELINES FOR EVALUATING EXPERIENCE FROM
A LICENSED OR A CERTIFIED RESIDENTIAL APPRAISER
WORKING TOWARD A NEW CLASSIFICATION**

The Board interpreted its rules from 7/2/07 through 11/20/08 as follows: a licensed or a certified residential appraiser working toward a new classification did not fall under the definition of "Trainee" and did not require a "Supervising Appraiser." On 11/20/08, the Board determined that a licensed or a certified residential appraiser working toward a new classification does fall under the definition of "Trainee" and does require a "Supervising Appraiser."

As a result of the Board's 11/20/08 interpretation of "Trainee", the Board will treat experience logs submitted by a licensed or a certified appraiser working toward a new classification as follows:

1. Experience without a supervising appraiser through 3/31/09 will be evaluated on experience logs submitted with applications filed by a licensed or a certified residential appraiser working toward a new classification.
2. Experience without a supervising appraiser on and after 4/1/09 will not be evaluated on experience logs submitted with applications filed by a licensed or a certified residential appraiser working toward a new classification.
3. A supervising appraiser supervising a trainee who is a licensed or certified appraiser working toward a new classification must comply with A.A.C. R4-46-201, including but not limited to, completing the required supervising appraiser/trainee course and filing a notification of engagement of trainee with the Board.
4. Pursuant to A.R.S. § 32-3615(A), each applicant for certification shall have experience that was acquired within ten years immediately preceding the filing of the application for certification.
